WAIVER OF LIABILITY: ASSUMPTION OF RISK

Any of its subsidiaries and other affiliates and any of their respective officers, directors, employees, agents, successors and assigns for any such personal injury (and no such person shall be liable for to member, member's spouse, children, unborn children, other family members, guests or invitees for any such personal injury), including without limitation, any activity held, organized or participated in by MCSWEENEY MARTIAL ARTS i) injuries arising from the participation in martial arts, self defense, fitness classes. ii) any physical activity supervised or unsupervised, with or without the use of training equipment including but not limited to, punching and kicking pads, hand held striking equipment, mats, shields, weapons, sticks, knives, swords, staffs gloves and all forms of protective equipment. iii) injuries or medical disorders resulting from participation in classes conducted by MCSWEENEY MARTIAL ARTS, or the practice of techniques learned away from scheduled class times at the members own discretion. Members shall indemnify MCSWEENEY MARTIAL ARTS, its subsidiaries and other affiliates and each of their respective officers, directors, employees, agents, successors or assigns (an "indemnified Party") and save and hold each of them harmless against and pay on behalf of or reimburse any such Indemnified Party as and when incurred for any losses which such indemnified party may suffer, sustain or become subject to as a result of, in connection with, relating or incidental to or by virtue of any claim that is the subject of the waiver set forth above. The provisions of this paragraph shall survive the termination of this agreement and member's membership.
